Henry Burnett, Jr. and Corror Jean Burnett, their heirs and assigns forever:

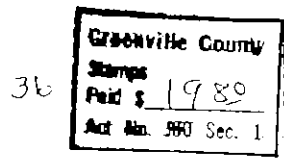
All that certain piece, parcel or lot of land, with all improvements thereon,
