Poore hereafter referred to as Grantee, at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the said Grantee James A. Poore, his heirs and assigns forever.

ALL that piece, parcel or lot of land situate, lying near the corporate limits of the City of Greenville, near the American Spinning Company, on Talley Street, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on Talley Street and running thence N. 20-10 E. 190 feet to an iron pin on a Ten foot alley; thence S. 68-50 E. 100 feet along said alley to an iron pin; thence S. 21-10 W. 190 feet to an iron pin on the North side of Talley Street; thence N. 68-50 W. 100 feet along said Talley Street to the beginning corner, and known as Lot No. 32 on a plat of same made by W. A. Hudson, Surveyor, of the Hammett Estate, said plat recorded in Plat Book A, Page 65.

This being the same property conveyed to the grantor by Laurence Gosnell by deed in Deed Book 470 at Page 105.

This deed is intended as a correction deed to the deed recorded in Deed Book 870 at Page 151. That deed refers to property located on Pinckney Street and gives as the deed reference for the grantors title Deed Book 235 at Page 152. Grantor Gosnell received his property which is located on Talley Street by a deed from Laurence Gosnell recorded in Deed Book 470 at Page 105. The property intended to be conveyed by the deed recorded in Volume 870 at Page 151 is described above.
