All that piece, parcel or lot of land situate in the State of South Carolina, County of Greenville, on the southeastern side of Crosby Circle, being known and designated as Lot No. 197, as shown on a Plat of Paramount Park, made by Piedmont Engineering Service, July, 1949, and recorded in the R.M. C. Office for Greenville County, in Plat Book "W", at Page 57, and having, according to said Plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the southeastern side of Crosby Circle, at the joint front corner of Lots 197 and 198; and running thence along the common line of said Lots S. 26-00 E. 150 feet to an iron pin; thence running S. 64-00 W. 70 feet to an iron pin at the joint rear corner of Lots 196 and 197; thence with the common line of said Lots N. 26-00 W. 150 feet to an iron pin on the southeastern side of Crosby Circle; thence with the line of said Crosby Circle N. 64-00 E. 70 feet to the point of beginning.
