in consideration of Fourteen Hundred and No/100 (\$1400.00)----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Alvin E. Smith, his heirs and assigns forever:

All those pieces, parcels or lots of land in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as Lots Nos. 24 and 27 of Enoree Hills, as shown on plat thereof by C. O. Riddle, Surveyor, dated July 1959 and recorded in the R. M. C. Office for Greenville County in Plat Book "MM", Page 197, and having, according to said plat, the following metes and bounds, to-wit:

LOT NO. 24: BEGINNING at an iron pin on the southern side of Burgess Drive at the joint front corner of Lots Nos. 24 and 25 and running thence along the line of Lot No. 25 S. 2-41 W. 184.9 feet to an iron pin; thence N. 74-50 W. 132 feet to an iron pin on the eastern side of Enoree Circle; thence along Enoree Circle N. 7-07 W. 64.8 feet and N. 2-41 E. 68 feet to an iron pin at the corner of the intersection of Enoree Circle and Burgess Drive; thence around the corner of said intersection and following the curvature thereof, the chord being N. 47-45 E. 35.3 feet, to an iron pin on the southern side of Burgess Drive; thence along Burgess Drive S. 87-19 E. 115 feet to the beginning corner.

LOT NO. 27: BEGINNING at an iron pin on the northern side of Burgess Drive at the joint front corner of Lots Nos. 27 and 28 and running thence along the line of Lot No. 28 N. 2-41 E. 200 feet to an iron pin in the line of Lot No. 31; thence along the line of Lot No. 31 S. 87-19 E. 193 feet to an iron pin in the line of property of Wade; thence along Wade's line S. 25-36 W. 217.1 feet to an iron pin on Burgess Drive; thence along Burgess Drive N. 87-19 W. 101.4 feet to the beginning corner.
