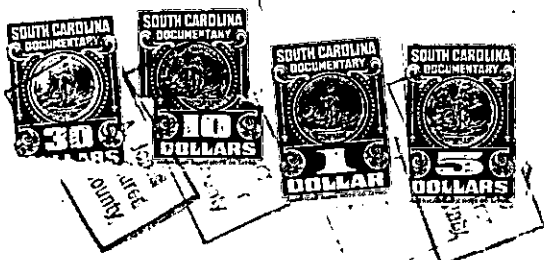

Cunningham Estate, as shown on plat dated June, 1925, of record in the RMC Office for Greenville County in Plat Book G, at pages 54 and 55, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin in the center of a County Road leading from Farris Bridge Road, which pin is N. 51-30 E. 532.8 feet from the intersection of said County Road and Farris Bridge Road; running thence N. 34-30 W. 382.4 feet to an iron pin; running thence N. 36-50 E. 387.7 feet to an iron pin; running thence S. 35-10 E. 480.7 feet to center line of road; running thence with center line of said road S. 51-30 W. 374 feet to the point of beginning.
