Haskell Ray Koon and Jennie Ruth M. Koon, their heirs and assigns:

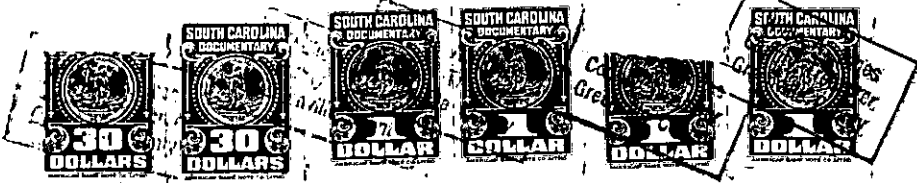
