ALL that certain piece, parcel or lot of land, situate, lying and being in the County of Greenville, State of South Carolina, being known and designated as Lot No. 13 on plat entitled "Final Plat Ogden Acres", prepared by Carolina Engineering and Surveying Co., dated September 25, 1964, and recorded in the RMC Office for Greenville County, S.C., in Plat Book BBB at Page 27, and having, according to said plat the following metes and bounds:

BEGINNING at an iron pin on the southeastern side of Ogden Drive at the joint front corners of Lots Nos. 12 and 13, and running thence with the line of Lot No. 12, S. 33-40 E. 129.0 feet to an iron pin; thence S. 56-10 W. 120 feet to an iron pin at the joint rear corner of Lots Nos. 13 and 14; thence with the line of Lot No. 14, N. 33-40 W. 129.0 feet to an iron pin on the southeastern side of Ogden Drive; thence with the southeastern side of Ogden Drive, N. 56-10 E. 120 feet to the point of beginning.

This conveyance is made subject to any restrictions, rights-of-way, or easements that may appear of record on the recorded plat(s) or on the premises.

As a part of the consideration hereof, the grantee agrees to assume and pay according to its terms, that certain note and mortgage given to Carolina Federal Savings & Loan Association, on which there is a balance due of \$ 10,150.00; said mortgage being recorded in Mortgages Volume 1000, Page 178.
