unto Larry R. Wall and Julie D. Wall, their heirs and assigns forever:

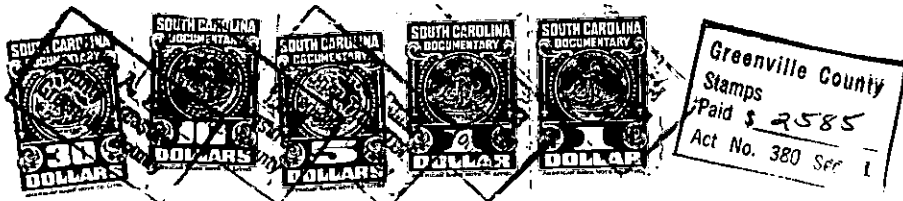
