All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the southeasterly side of Castlewood Drive, near the City of Greenville, S. C., being known and designated as Lot No. 51 on plat entitled "Final Plat Revised Map No. 2 Foxcroft, Section II" as recorded in the RMC Office for Greenville County, S. C. in Plat Book 4N, pages 36 and 37 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeasterly side of Castlewood Drive, said pin being the joint front corner of Lots 51 and 52 and running thence with the common line of said Lots S 65-36 E 165 feet to an iron pin, the joint rear corner of Lots 51 and 52; thence S 26-21 W 106.8 feet to an iron pin, the joint rear corner of Lots 51 and 50; thence with the common line of said Lots N 74-14 W 150 feet to an iron pin on the southeasterly side of Castlewood Drive; thence with the southeasterly side of Castlewood Drive N 15-46 E 43.8 feet to an iron pin; thence continuing with said Drive N 20-05 E 86.2 feet to an iron pin, the point of beginning.
