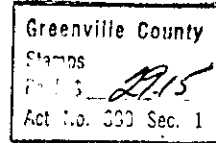
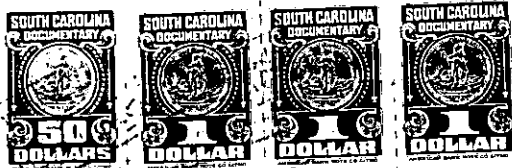
KNOW ALL MEN BY THESE PRESENTS, that we, Woodrow W. McClendon and Margaret P. McClendon,
