All that piece, parcel or lot of land in Austin Township, Greenville County, state of South Carolina, in the town of Mauldin, S.C., being known and designated as Lot No. 19, on Map No. 2, of Sunset Heights made by C. O. Riddle, September 17, 1953 and having according to said plat the following metes and bounds, courses and distances, to-wit:
