in consideration of ONE THOUSAND ONE HUNDRED AND NO/100-----(\$1,100.00)----- Dollars,

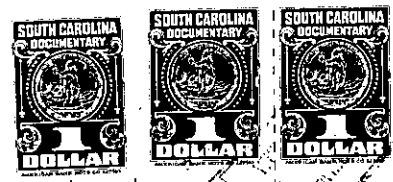
