MRS. RUTH W. DYER and LINDA K. DYER, their heirs and assigns forever:

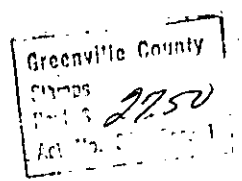
All that certain piece, parcel or lot of land in Greenville County, State of South Carolina,
