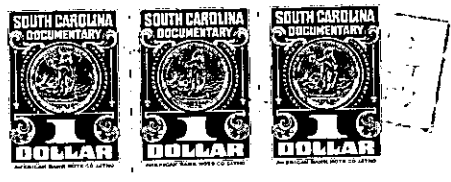
in consideration of Fifteen Hundred and No/100 (\$1500.00)-----Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Lillian R. Hall, her heirs and assigns forever:

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being known and designated as Lot No. 64 of a subdivision known as Pine Hill Village as shown on plat prepared by R. K. Campbell, R. L. S., November 30, 1960, and recorded in the R. M. C. Office for Greenville County in Plat Book QQ at Page 168, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western edge of Daisy Drive at the joint front corner of Lots 63 and 64 and running thence along the joint line of said lots, N. 79-11 W. 140 feet to an iron pin at the joint rear corner of Lots 136 and 137; thence along the rear line of Lot 136 (this being the center of a 67-foot Duke Power Co. transmission line R/W and the western edge of a 10-foot sanitary sewer easement), S. 10-49 W. 70 feet to an iron pin at a rear corner of Lot 65; thence along the line of Lot 65 (this being the southern edge of said 10-foot sanitary sewer easement), S. 79-11 E. 140 feet to an iron pin on the western edge of Daisy Drive; thence along the western edge of Daisy Drive, N. 10-49 E. 70 feet to the beginning corner;

This conveyance is subject to restrictions and protective covenants recorded in the R. M. C. Office for Greenville County in Deed Vol. 665, at Page 465 and Deed Vol. 703 at Page 351, and is also subject to utilities and drainage easements which appear of record.
