AGREEMENT

In consideration of the sum of Ten Dollars (\$10.00) and other valuable considerations satisfactory to me, including assumption of maintenance of the lines, I, Homer Styles, do hereby transfer, convey and set over to Parker Water and Sewer Sub-District Commission, its successors and assigns, all water lines installed by me on the streets listed below which to the best information available are as follows:

- 542 feet of 2 inch line on Linda Lane;
- 388 feet of 3 inch line on Linda Lane;
- 105 feet of 2 inch line on Montis Drive;
- 126 feet of 3 inch line on Montis Drive;
- 2,540 feet of 4 inch line on Montis Drive;
- 1,209 feet of 6 inch line on Perry Road;
- 744 feet of 4 inch line on Perry Road;
- 737 feet of 2 inch line on Perry Road;
- 911 feet of 2 inch line on Merrydale Lane;
- 794 feet of 2 inch line on Marshall Court;
- 938 feet of 2 inch line on Cortney Circle;
- 1,149 feet of 2 inch line on Duncan Chapel Road;
- 1,250 feet of 6 inch line on Poinsett Highway;
- 345 feet of 2 inch line on Poinsett Highway;
- 500 feet of 6 inch line on Cope Circle;
- 330 feet of 3 inch line on Cope Circle;
- 1,100 feet of 2 inch line on Cope Circle;

it being my intention to divest myself of any right, title and interest to any water lines which I may have installed on such streets, and to absolve myself of any obligation or duty to maintain any such lines, together with all valves, fittings and other accoutrements, fixtures or attachments thereto.\* I further warrant that the lines installed by me are fully paid for and no liens or claims exist against such lines, and they are being conveyed to Parker Water and Sewer Sub-District Commission since the area serviced by these lines has been incorporated into Parker Water and Sewer Sub-District and the Commission for such Sub-District has agreed to maintain such lines.
