KNOW ALL MEN BY THESE PRESENTS, that Frances Elizabeth Ellison,

in consideration of Seven thousand and no/100-----Dollars, (\$7,000.00) the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Claudia B. Harbit, her heirs and assigns forever:

ALL That lot of land situate on the western side of Tanyard Road in the county of Greenville, state of South Carolina, being shown as a tract containing seven acres, more or less, on a plat of the property of Mrs. Frances Ellison dated April 28, 1972 prepared by Webb Surveying & Mapping Company, recorded in Plat Book 1 at Page 6 in the RMC Office for Greenville County and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING At a nail and cap near the center of Tanyard Road, which nail and cap is approximately 1,485 feet in a northern direction from Buckhorn Road and running thence with Tanyard Road, N. 12-05 W. 4.00 feet to a nail and cap near the center of a bridge over a creek passing under Tanyard Road; thence with the creek as the line, the following courses and distances: N. 89-24 W. 142.9 feet; S. 67-03 W. 98.8 feet; N. 78-27 W. 255 feet; N. 74-37 W. 188 feet to an iron pin; thence leaving said branch and running with the Ellison property, S. 24-41 E. 849.2 feet to an iron pin; thence still with the Ellison property, N. 51-04 E. 502.7 feet to the point of beginning.

This is a portion of the property conveyed to Jewell Overland Ellison and Frances Elizabeth Ellison by deed recorded in Deed Book 703 at Page 477 in the RMC Office for Greenville County. The said Jewell Overland Ellison died testate on August 30, 1968, devising his interest in the said property to the Grantor herein, as will appear according to Apartment 1045, File 1 in the office of the Probate Court for Greenville County.

This property is conveyed subject to all restrictions, zoning ordinances, easements of record or on the ground affecting said property.

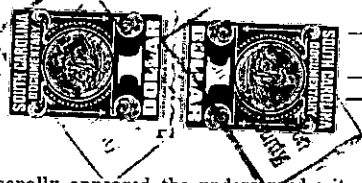
