KNOW ALL MEN BY THESE PRESENTS, that ALBERTA GILBERT

in consideration of FOUR THOUSAND THIRTY FIVE and 14/100 (\$4,035.14)-----Dollars  
AND ASSUMPTION OF MORTGAGE INDEBTEDNESS SET FORTH BELOW:  
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto ERNEST D. TEEMS, his heirs and assigns forever:

ALL that piece, parcel or lot of land, together with buildings and improvements, situate, lying and being at the Northwestern corner of Wilton Street with Randall Street, in the City of Greenville, Greenville County, South Carolina, being shown and designated as Lot No. 22 on a Plat of Section A of STONE LAND COMPANY, recorded in the RMC Office for Greenville County, South Carolina in Plat Book A, Pages 337 and 345, and having according to a more recent survey thereof made by R. K. Campbell in 1964, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the Northwestern corner of the intersection of Wilton Street with Randall Street and running thence along the Northern side of Randall Street, N. 83-36 W., 108.75 feet to an iron pin; thence N. 2-10 E., 69.5 feet to an iron pin; thence S. 81-19 E., 108.79 feet to an iron pin on the Western side of Wilton Street; thence with the Western side of Wilton Street, S. 2-04 W., 65 feet to an iron pin, the point and place of beginning.

The above described property is the same conveyed to the Grantor herein by deed of Margaretha Schroeder recorded in the RMC Office for Greenville County, South Carolina in Deed Book 898, Page 192, and is hereby conveyed subject to rights of way, easements, conditions, public roads and restrictive covenants reserved on plats and other instruments of public record and actually existing on the ground affecting said property.

As a part of the consideration for this deed, the Grantee assumes and agrees to pay in full the indebtedness due on a note and mortgage to Cameron-Brown Company in the original amount of \$9,900.00 dated February 12, 1965, recorded in Mortgage Book 972, Page 367, on which there is a present balance due in the amount of \$7,184.38. As a further part of the consideration for this deed, the Grantor assigns and transfer to Grantee all right, title and interest in and to any escrow deposits maintained by the above named Mortgagee in connection with the mortgage loan referred to above.

The Grantee agrees to pay City of Greenville and Greenville County property taxes for the tax year 1972 and subsequent years.

together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee's(s') heirs or successors and assigns, forever. And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee's(s') heirs or successors and assigns against the grantor(s) and the grantor's(s') heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

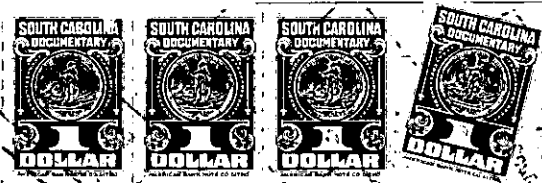
