in the State aforesaid, in consideration of the sum of One Thousand Two Hundred Fifty and No/100-----DOLLARS, (\$1,250.00)

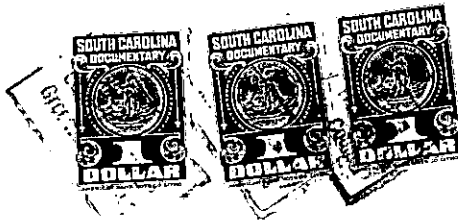

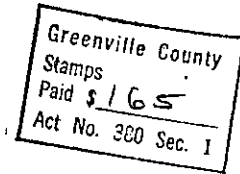
