KNOW ALL MEN BY THESE PRESENTS, that I, Ola S. Burger,

in consideration of (\$2,500.00) Two Thousand Five Hundred and No/100----- Dollars,
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto William R. Camp, his heirs and assigns forever:

ALL those two parcels, pieces or lots of land in Greenville County, South Carolina, being a portion
of Lot No. 1 and Lot No. 0 as shown on a plat of Norwood Heights, recorded in R. M. C. Office For
Greenville County in Plat Book "A" at Page 133, having together the dimensions of 100 feet by 30 feet
and more fully described as follows:

PARCEL "A": BEGINNING at a pin on East Fifth Street (Birnie Street) 10 feet East of the Eastern line
of PARCEL "B" and running thence parallel with the alley in a Southerly direction 100 feet to a pin;
thence in a Westerly direction 30 feet, more or less, to a pin on an alley; thence with the Eastern side
of the alley 70 feet to a pin at the rear corner of PARCEL "B"; thence with PARCEL "B" in a Westerly
direction 20 feet to a pin; thence still with PARCEL "B" in a Northerly direction 30 feet to a pin;
thence with the South side of East Fifth Street (Birnie Street) 30 feet to the point of BEGINNING.

PARCEL "B": Beginning at a point on the South side of East Fifth Street (Birnie Street) which point is
150 feet West of the intersection of Vance Street and East Fifth Street, and is on the corner of an
alley leading to Woodside Mill, and running thence with said alley, S. 15 1/2 W., 30 feet to a stake;
thence S. 7 1/4 E., 20 feet to a stake; thence N. 15 1/2 E., 30 feet to a stake on the South side of East
Fifth Street (Birnie Street); thence with East Fifth Street N. 7 1/4 W., 20 feet to the corner of
