THIS WARRANTY DEED, made this 30th day of August, 19 72,
between Brown Enterprises of S.C., Inc.,
of Greenville County, State of South Carolina, Grantor(s);
and Joseph P. Dockery and Deborah C. Dockery
of Greenville County, State of South Carolina, Grantee(s);

WITNESSETH: That the said grantor(s) for and in consideration of the sum of Eighteen Thousand Two
Hundred and No/100 Dollars (\$18,200.00),
to it in hand paid by the Grantee(s), the receipt whereof is hereby acknowledged, ha S

granted, bargained, sold and conveyed and by these presents do es herey grant, bargain,
sell and convey unto the said Grantee(s) for and during their joint lives and upon the death of either of them, then to the
survivor of them, his or her heirs and assigns forever in fee simple, together with every contingent remainder and right of
reversion, the following described land, lying and being in the County of Greenville,
State of South Carolina, to-wit:

ALL that piece, parcel or lot of land situate, lying and being
in the County of Greenville, State of South Carolina, and
being known and designated as Lot No. 2 of Caravelle Subdivision,
and, according to a plat prepared of said Subdivision by R. B.
Bruce, Reg. L.S., February 10, 1972, and recorded in the R.M.C.
Office for Greenville County, South Carolina, in Plat Book 4N, at
Page 61, having the following courses and distances, to-wit:

BEGINNING at a point on the edge of McElhaney Road, joint front
corner of Lots Nos. 2 and 3, and running thence with the joint
line of said lots, N. 18-31 W. 149.2 feet to a point; thence
running, N. 85-26 E. 88 feet; thence, S. 19-15 W. 140 feet to a
point on the edge of McElhaney Road; thence running with said
road, S. 79-19 W. 88 feet to a point, the point of beginning.

This being a portion of the same property conveyed the Grantor
herein by deed dated March 23, 1972, and recorded in the R.M.C.
