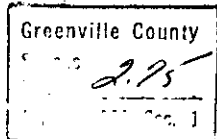

ALL that piece, parcel or lot of land in Highland Township, Greenville County, State of South Carolina, on County Road just off the Old Factory Road near Skyland School and being a portion of that property conveyed to the grantors herein by deed of A. C. Few and Nancy S. Few recorded in the R.M.C. Office for Greenville County in Deed Book 844 at page 27, a plat of same being recorded in the R.M.C. Office for Greenville County in Plat Book XXX at page 153; and the property conveyed herein having the following metes and bounds according to plat entitled Property of Billy Alvin Jenkins and Sandy K.
