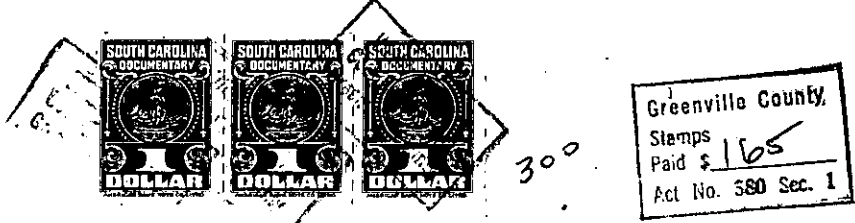
KNOW ALL MEN BY THESE PRESENTS, that I, Ward S. Stone, of Greenville County

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto  
Chas. A. Mundy, his heirs and assigns forever:

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being known and designated as Lot No. 207 of a subdivision known as Pine Hill Village as shown on plat prepared by R. K. Campbell, R.L.S., November 30, 1960, and recorded in the R.M.C. Office for Greenville County in Plat Book QQ at Page 168, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of East Castle Road at the joint front corner of Lots 206 and 207 and running thence along the joint line of said lots, S. 58-49 W. 133.2 feet to an iron pin in the rear line of Lot 42; thence along the line of that lot, S. 15-46 E. 25 feet to an iron pin in the rear line of Lot 41; thence along the line of that lot, S. 25-47 E. 59.4 feet to an iron pin at the rear corner of Lot 208; thence along the line of that lot, N. 56-01 E. 139.1 feet to an iron pin on the western side of East Castle Road; thence along the western side of East Castle Road, N. 26-20 W. 76.7 feet to the beginning corner;
