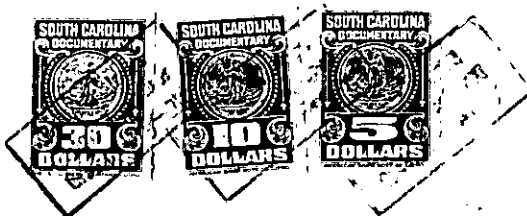
KNOW ALL MEN BY THESE PRESENTS, that SAMUEL H. DUVALL, JR.

DEMPSEY L. POOLE, JR. AND GRACE G. POOLE, THEIR HEIRS AND ASSIGNS FOREVER:

ALL that piece, parcel or lot of land, with improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the Town of Simpsonville, on the Southern side of Seminole Drive, being shown as Lot No. 21 on Plat No. 5 of West Georgia Heights, recorded in Plat Book GGG at page 120 in the RMC Office for Greenville County, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Southern side of Seminole Drive at the joint front corner of Lots 21 and 20, and running thence with the joint line of said lots, S. 0-53 W., 200 feet to an iron pin; thence S. 89-47 E., 100 feet to an iron pin at the joint rear corner of Lots 21 and 22; thence with the joint line of said lots, N. 0-53 E., 200 feet to an iron pin on the Southern side of Seminole Drive; thence with the side of said drive, N. 89-47 W., 100 feet to an iron pin at the point of beginning.
