We, Travis Waldrop and Pauline Waldrop,

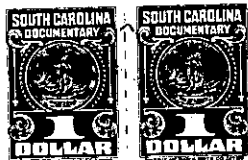
in consideration of One-Thousand and no/00 (\$1,000.00)----- Dollars,
