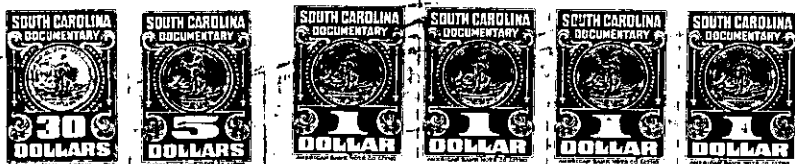
KNOW ALL MEN BY THESE PRESENTS, that WILLIAM LAWRENCE HAMBY.
