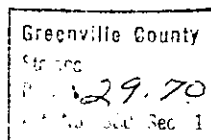
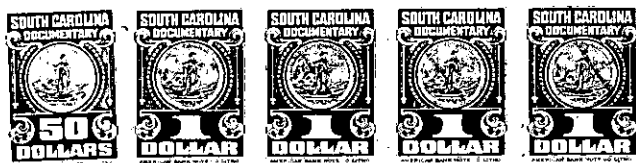
in consideration of Twenty-six Thousand Seven Hundred (\$26,700.00) Dollars,

Riddle, September 17, 1953 and having according to said plat the following metes and bounds, courses and distances, to-wit:
