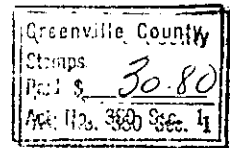
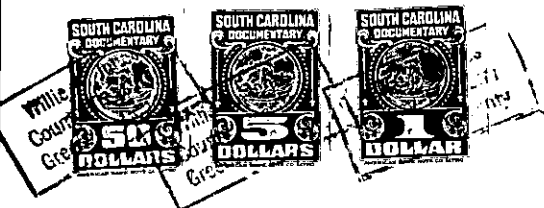
in consideration of TWENTY EIGHT THOUSAND (\$28,000.00) ----- Dollars,
