KNOW ALL MEN BY THESE PRESENTS, that **CENTRAL REALTY CORPORATION**

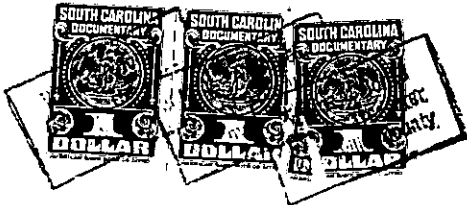

ALL that certain piece, parcel, or lot of land in Austin Township, Greenville County, State of South Carolina, within the corporate limits of the Town of Mauldin, and being known and designated as Lot Number 7 of a subdivision known as Glendale II, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book 000 at Page 55, and having the following metes and bounds, to wit:

BEGINNING at a point on the Northwestern side of Hickory Lane at the joint front corner of Lots 6 and 7 and running thence with the Northwestern side of Hickory Lane N 51-07 E 65.2 feet to a point; thence continuing with the Northwestern side of Hickory Lane N 59-05 E 25 feet to a point at the joint front corner of Lots 7 and 8; thence N 30-55 W approximately 171.5 feet to a point in a branch at the joint rear corner of Lots 7 and 8; thence with said branch as a line approximately S 55-30 W approximately 139.6 feet to a point in said branch at the joint rear corner of Lots 6 and 7; thence S 47-04 E approximately 178.9 feet to a point on the Northwestern side of Hickory Lane at the point of Beginning.

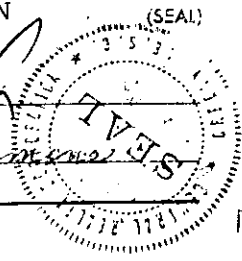
