Beginning on the Southern side of road that leads off Hammett Bridge Road at the joint corner of lots 5 and 6 and running thence as the common line of lots 5 and 6, S. 20-02 W., 180 feet to the joint rear corner of lots 5, 6 and 4; thence as the common line of lots 4 and 5, N. 50-05 W., 150 feet to the eastern side of a street; thence along the eastern side of a street, N. 34-46 E., 133.7 feet to angle; thence along the southern side of street, S. 69-58 E., 107 feet to the beginning corner.
