

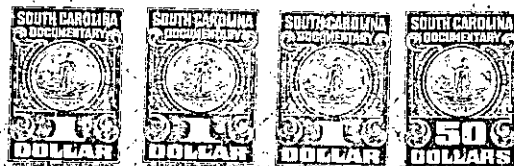
KNOW ALL MEN BY THESE PRESENTS, that **Project 20, Inc.**
