in consideration of Sixteen Thousand and No/100ths----- Dollars,

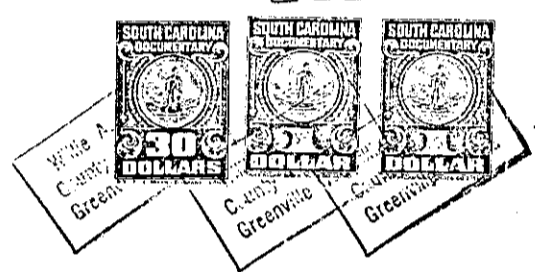
