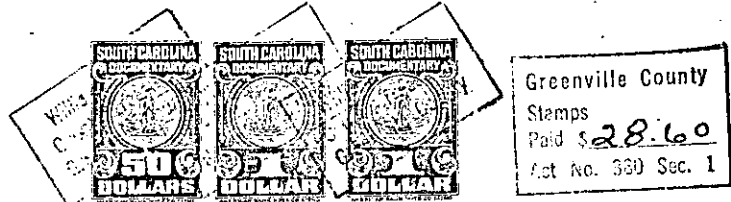
KNOW ALL MEN BY THESE PRESENTS, that I, Harry M. Alexander,

All that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being known and designated as Lot No. 23 of a subdivision known as Oakwood Acres, as shown on plat prepared by J. Mac Richardson, dated September 1959, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book MM, at Page 135, and according to said plat having the following metes and bounds, to-wit:
