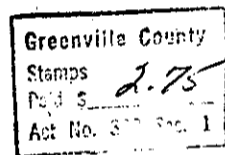
In consideration of Two Thousand Three Hundred Two and 78/100 (\$2,302.78) ----- Dollars,
