ALL OF OUR UNDIVIDED RIGHT, TITLE AND INTEREST IN AND TO:

ALL that piece, parcel and lot of land lying and being in Gantt Township, County and State aforesaid, near the City of Greenville, containing .25 of an acre, according to survey made by J. Mac Richardson, Reg. Land Surveyor, dated November, 1951 and being shown on that Plat as Lot No. 2. It begins on the southern edge of a proposed 30 foot street 118 feet N. 76-35 W. from the White Horse Mill property and runs thence along the southern edge of the proposed street N. 76-35 W. 118 feet to corner on Bowen; thence along Bowen S. 34-00 W. 100 feet to corner; thence S. 76-35 E. along Bowen's land 118 feet to corner on lot Number 1 of the Richardson survey; thence by a dividing line between lot number 1 and lot number 2 N. 34-00 E. 100 feet to the beginning corner and being a portion of the land purchased from Bessie Lenhardt.

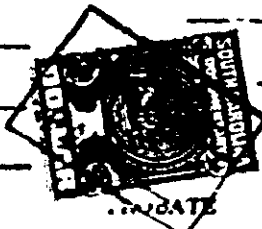
