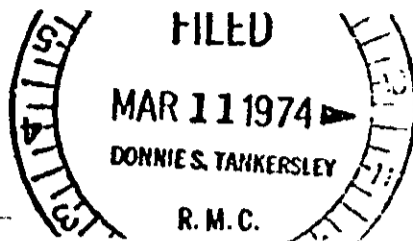

THESE LOTS ARE BOUNDED BY: NORTH - LOT 11, M.N. M8.3 BLOCK 1 OWNED BY ELEANOR WORT BISHOP  
SOUTH - LOT 8, M.N. M8.2 BLOCK 1 OWNED BY DOROTHY T. CHANDLER EAST - LOT 1, M.N. M8.2, BLOCK 1 OWNED BY THOMAS W. EDWARDS WEST - LAUREL CREEK

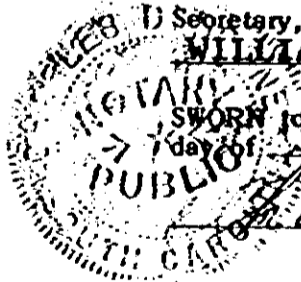
