the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Cleone J. Bull, her heirs and assigns forever:

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 76 of a subdivision known as Pebble Creek, Phase I as shown on plat thereof prepared by Enwright Associates, Engineers, dated October 1973, and recorded in the R. M. C. Office for Greenville County in Plat Book 5-D at Page 2 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern edge of Whittlin Way, joint front corner of Lots Nos. 75 and 76, and running thence along the joint line of said lots, N. 78-15 E. 187.63 feet to an iron pin on the line of Fairway No. 10; thence along the line of said fairway, N. 21-13 W. 121.65 feet to an iron pin; thence S. 78-15 W. 20 feet to an iron pin at a rear corner of Lot No. 77; thence following the same course, S. 78-15 W. 147.63 feet to an iron pin on the eastern edge of Whittlin Way; thence along the eastern edge of Whittlin Way, S. 11-45 E. 120.0 feet to the beginning corner.
