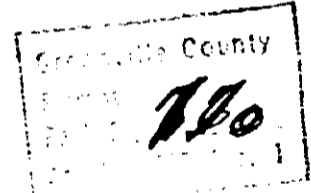
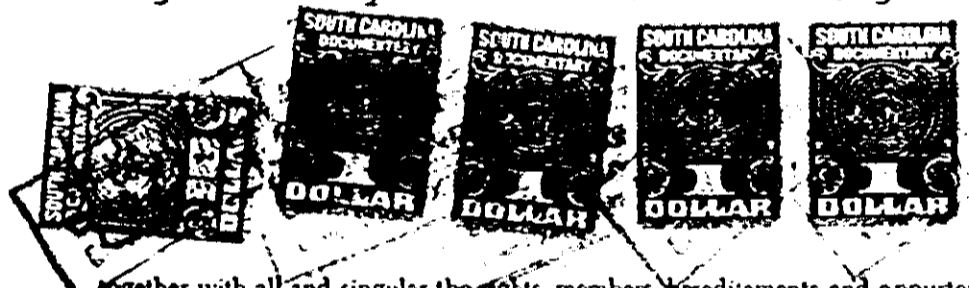

All that piece, parcel or lot of land in O'Neal Township, Greenville County, state of South Carolina, on the south side of Ponder Road (sometimes called Gibson-Mosteller Road) containing 5.74 acres as shown on plat prepared by Piedmont Engineers, March 12, 1974 and being a portion of Tract No. 2 on plat entitled "Property of Benjamin Perry and James T. Ponder" dated July 2, 1971 by H. S. Brockman, R.L.S. recorded in the RMC Office for Greenville County, S. C. in plat book 4-K page 197 and being more particularly described as follows:
