release unto ALFRED L. BIXLER, JR. AND RITA J. BIXLER, their heirs and assigns forever:

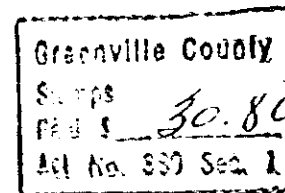
All that certain piece, parcel or lot of land in Greenville County, State of South Carolina,
