ALL that piece, parcel or lot of land, situate, lying and being in the County of Greenville, State of South Carolina, on the southeastern side of Lancelot Drive, being known and designated as Lot No. 25 as shown on plat entitled CAMELOT, dated November 5, 1968, prepared by Piedmont Engineers & Architects, and recorded in the R.M.C. Office for Greenville County, in Plat Book WW, at Page 47, and having, according to said plat, the following metes and bounds, to-wit:
