ALL water lines, mains, valves and appurtenances installed and located in, under or along Clingmore Court, Sagramore Court, Sagramore Lane, County of Greenville, State of South Carolina, including approximately 1,610 feet of 6 inch pipe, 760 feet of 2 inch pipe, 1 - 6 inch valve, 4 - 2 inch valves, and 1 fire hydrant, and is shown on a drawing entitled "Camelot, Inc. to Commissioners of Public Works of the City of Greenville, S.C.", dated September 23, 1974, attached hereto and made a part of this conveyance.

TOGETHER with all other mechanical parts and equipment appurtenant to said lines and all rights of way and easements necessary or incident to the operation, maintenance, repair or replacement of said water lines and appurtenances.
