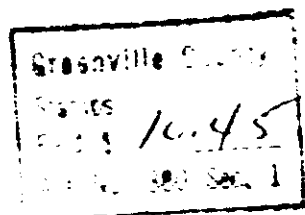

C., in Plat Book 5D, at Page 18, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the westerly side of Lake Water Court, said pin being the joint front corner of Lots 256 and 257 and running thence with the common line of said lots N 61-26-34 W 187.09 feet to an iron pin, the joint rear corner of Lots 256 and 257; thence S 59-53-33 W 42.11 feet to an iron pin; thence S 21-03-14 W 160 feet to an iron pin; thence turning and running N 77-59-11 E 110.24 feet to an iron pin on the westerly side of Lake Water Court; thence with the westerly side of Lake Water Court on a curve the chord of which is N 26-40 E 46.15 feet; thence continuing on a curve the chord of which is N 41-14 E 22.4 feet to an iron pin, the point of beginning.
