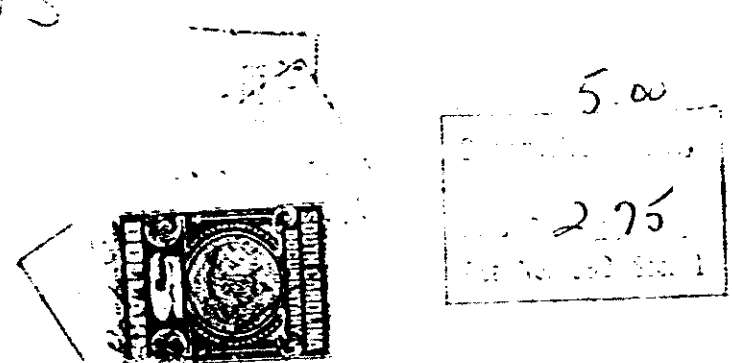
All that piece, parcel, or lot of land, lying and being in Cleveland Township, County of Greenville, State of South Carolina, known as Lot # 9, as shown on plat dated January 20, 1962, of the Georgia-Pacific Corporation, and recorded in Plat Book YY, Page 51, and the community known as Pine Ridge, being one of the lots purchased by M. L. Jarrard from Georgia-Pacific Corporation, March 6, 1962, as recorded in Volume 693, Page 459, having the following metes and bounds, to-wit:

BEGINNING at a point in the center of Pine Ridge Road at the Joint Corner of Lots 9, 10, 20, and 21 running thence with the line of Lot #10 S. 74 - 30 E. 234.4 feet to an iron pin, line of Cleveland Property; thence S. 4 - 22 E. with the Cleveland line 160 feet to an iron pin, corner of Lot #8; thence with Lot #8 N. 55 - 45 W. 287 feet to a point in the center of Pine Ridge Road; thence with center of said road N. 1-10 W. 60.9 feet to the beginning corner. This lot containing 0.58 acres, more or less.

It is further agreed in buying this house that the buyer is to share ownership and responsibilities of a community well supplied by the seller at no extra cost except for a monthly water bill along with any other cost of maintenance. It is understood that those in charge of the community well shall have right-of-way to maintain, add, or replace necessary water lines to service all houses involved in this project.
