in consideration of Five thousand and no/100 (\$5,000.00) Dollars,

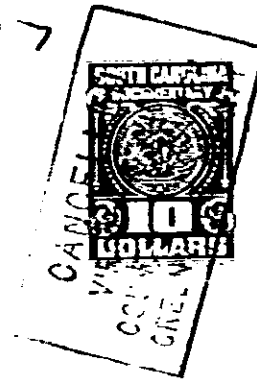
