All that certain piece, parcel or lot of land situate, lying, and being in Greenville County, South Carolina shown as Lot Number Three (3) on Plat Number One (1) entitled survey for C. H. Duck, Estate and having the following metes and bounds to-wit:

Beginning at a point on unpaved road and running thence N82 35W 120 feet to a point; thence continuing N56 03W 130 feet to a point; thence leaving said road N37 14E 1,213.8 feet to an iron pin; thence S21 35E 235.5 feet to an iron pin; thence S42 25E 121.1 feet to an iron pin; thence S42 11W 1,006.7 feet to the point of beginning.
