and assumption of mortgage as set out below:

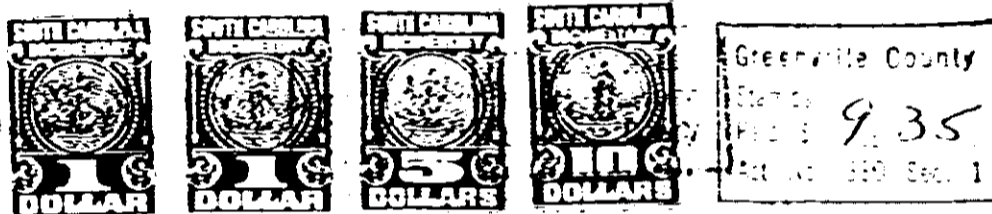
