KNOW ALL MEN BY THESE PRESENTS, that Montgomery, Inc.

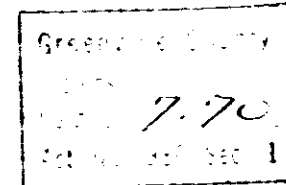
