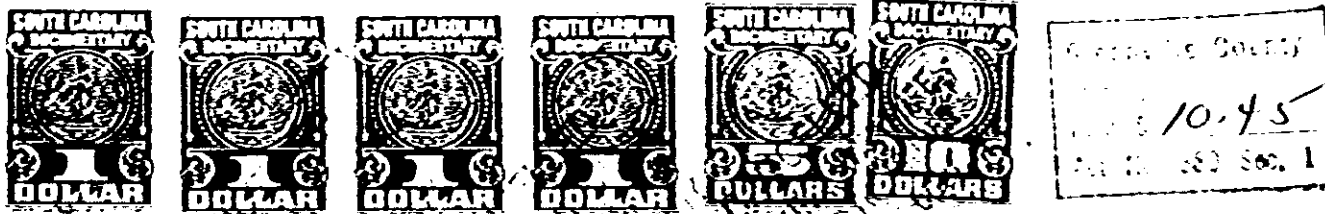
KNOW ALL MEN BY THESE PRESENTS, that Southland Properties, Inc.

All that certain piece, parcel or lot of land, situate, lying and being in
the State of South Carolina, County of Greenville, being known and designated as Lot No. 6
of a subdivision known as River Downs according to a plat thereof prepared by Piedmont
Engineers, Architects and Planners dated July 17, 1974, and recorded in the RMC Office
for Greenville County in Plat Book 4-R at pages 75 and 76 and having, according to said
