GEORGE O'SHIELDS BUILDERS, INC., Its Successors and Assigns:

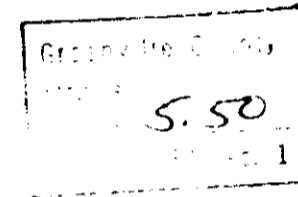
