in consideration of ---One Thousand Five Hundred and no/100 (\$1,500.00)--- Dollars,

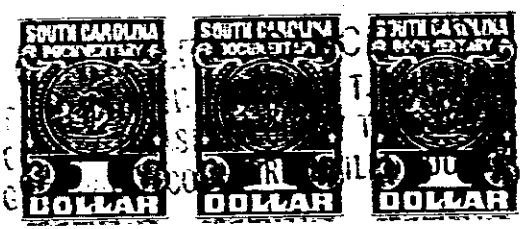
