All that piece, parcel or lot of land lying and being situate on the Easterly side of French Lane in Gantt Township, near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 112, according to plat of Pine Hill Village, prepared by R. K. Campbell, Surveyor, dated November 30, 1960, as recorded in the RMC Office for Greenville County, South Carolina in Plat Book QQ at Page 169, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Easterly side of French Lane at the joint front corner of Lots 111 and 112, and running thence along said joint line N. 71-44 E. 131.2 feet to an iron pin at the joint rear corner of Lots 111 and 112; thence along the rear line of Lot 90, N. 15-46 W. 72 feet to an iron pin at the joint rear corner of Lots 112 and 113; thence along the joint line of said lots, S. 71-44 W. 132.9 feet to an iron pin on the Easterly side of French Lane; thence along said French Lane, S. 17-04 E. 72 feet to an iron pin at the joint front corner of Lots 111 and 112, the point of beginning.

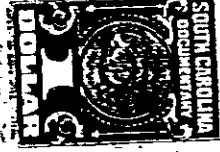
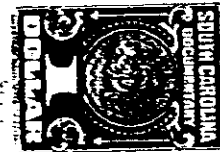
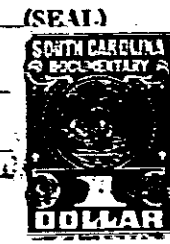
